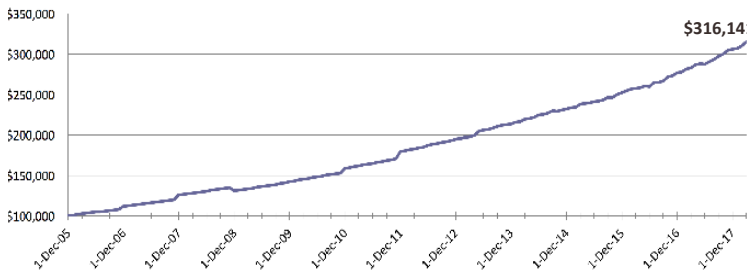
The Strategy

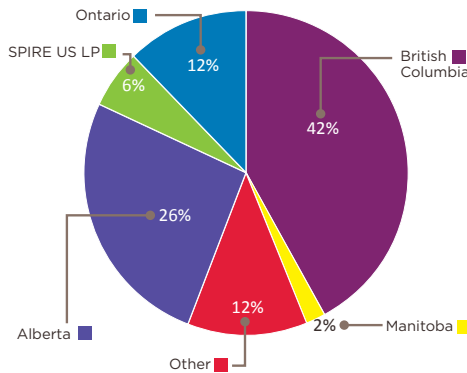
The Manager

Holdings By Region as of March 31, 2018

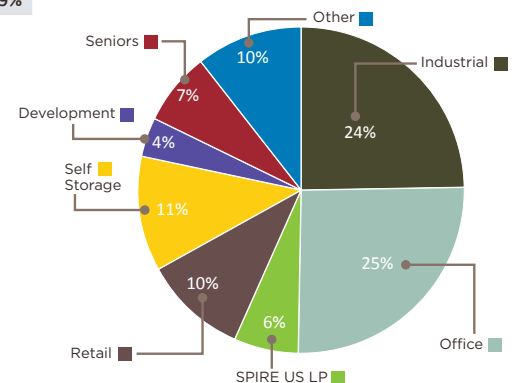
